

2. Further, it is instructed that no next higher standard(s) should be opened without prior permission of the competent authority. The recognition will be withdrawn unless the conditions stipulated above and those prescribed in the Pondicherry School Education Rules, 1996 are fulfilled within the above said period by the Educational Agency concerned.


